

SECOND AMENDMENT TO THE STANDBY TRUST AGREEMENT

SECOND AMENDMENT TO THE STANDBY TRUST AGREEMENT, dated as of April 12, 2018 ("SECOND AMENDMENT") among Homestake Mining Company of California, a California corporation, Citibank, N.A., a national bank, and U.S. Nuclear Regulatory Commission.

1. Schedule A of the STANDBY TRUST AGREEMENT, dated November 13, 2013 is amended in its entirety as follows:

The cost estimates listed here, approved by the NRC in 2017, reflect an increase in costs for decommissioning the materials and activities identified in License Number SUA-1471 due to reclamation work completed by Homestake Mining Company of California, insofar as such costs were previously approved by the NRC on March 16, 2016 in the amount of \$62,490,490.

2. Except as set forth in this Second Amendment, the Standby Trust Agreement is unaffected and shall continue in full force and effect in accordance with its terms. If there is a conflict between this Second Amendment and the Standby Trust Agreement, the terms of this Second Amendment will prevail.
3. This Second Amendment shall be governed by and construed in accordance with the laws of the State of New York.
