In Reference 1, Louisiana Energy Services (LES), dba URENCO USA (UUSA), requested an amendment to its Safety Analysis Report to allow UUSA to feed UF<sub>6</sub> greater than 0.72 wt % <sup>235</sup>U, but less than 1 wt % <sup>235</sup>U. A License Amendment Request is necessary to implement this change as it requires NRC approval in accordance with SNM-2010 License Condition 30.
