Dear Mr. Parks:

By letter dated November 1, 2018 (Agencywide Documents Access and Management System [ADAMS] Accession Number ML18305A356), you notified the U.S. Nuclear Regulatory Commission (NRC) that as of October 12, 2018 that CB&I AREVA MOX Services (MOX Services) ceased NRC regulated construction activities on the Mixed Oxide Fuel Fabrication Facility (MFFF). This followed receipt of a Notice of Termination from the U.S. Department of Energy, National Nuclear Security Administration of the contract to design, build and operate the MFFF. Due to the cessation of NRC regulated activities and the Notice of Termination, MOX Services requested the NRC to terminate the Construction Authorization (CA).

Revision 5 of the CA which terminates NRC regulated activities at the MFFF, is provided in Enclosure 1 to this letter. The NRC staff report documenting its review for this licensing action is provided in Enclosure 2 to this letter.

In accordance with title 10 of the *Code of Federal Regulations* Section 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of the NRC's ADAMS.
