In response to your letter dated November 8, 2018 (Agencywide Document Access and Management System [ADAMS] Accession Number ML18317A057), transmitting the triennial update of your decommissioning funding plan, and pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 70, the U.S. Nuclear Regulatory Commission (NRC) is amending Materials License SNM-1227 to approve the revised plan.

Safety Condition S-1 of your license is amended to add the date of November 8, 2018. All other conditions of this license shall remain the same. The amended license and a safety evaluation report is enclosed. This letter concludes staff action on this request and Enterprise Project Identifier L-2018-DFA-0010 is considered closed.
