Draft Options

- Sliding Scale
- Industry's Security Bounding Time (SBT)
 White Paper
- Consideration of 10 CFR 50.47



Sliding Scale Option

- Site-specific credit based on:
 - Level of coordination, planning, and training between licensees and law enforcement (LE) responders
 - Area of the site in which law enforcement assistance would be needed (i.e., owner controlled area, exterior portions of a protected area, inside site structures)
- Uses standardized criteria to evaluate coordination, planning, and training
- Cover six types of incident response preparation
- Guiding principle: more criteria met = better LE preparedness = greater licensee credit
- Example of potential credit: Add operator actions & equipment (e.g., FLEX) to target sets



Documentation

- Commitments
- Plans
- Training
- Corrective actions
- Lessons learned

Information Exchange

- Site information provided in advance
- Contingency Response Tools
- Tactical Mission Planning Package
- Periodic review and update of plans

Familiarization Activities

- Information on site security, adversary, & law enforcement capabilities
- Periodic walk-downs of areas related to law enforcement support
- Environmental hazards
- Lessons inform planning, training and documentation

Tabletop Discussions

- Periodicity
- Involve site and law enforcement management
- Lessons inform planning, training and documentation

Communications

- Primary, secondary, and tertiary systems and protocols
- Individual- or command center-based
- Periodic onsite testing, including of law enforcement equipment
- Frequency map documented and included in plans
- Lessons inform planning, training and documentation

Training and Validation

- Periodic functional exercises (permissive environment)
- Periodic field exercises (simulated combat environment)
- Lessons inform planning, training and documentation

Law Enforcement Preparedness (increasing)

Industry's SBT Proposal

- Site-specific credit based on a 6-step process and security coping time formulas
- Security coping time formulas by support area:
 Owner Controlled Area and Protected Area
- Example of potential credit: Add operator actions & equipment (e.g., FLEX) to target sets



Consideration of 10 CFR 50.47

- Option for Commission to equate offsite response actions off licensee property under 10 CFR 50.47(c)(1)(iii)(B) with offsite response actions on licensee property, including potentially inside protected areas
- Would likely establish the same security coping time for every power reactor site
- May consider establishing security coping times in tiers, likely based on licensees' geographic proximity to LE assistance
- Would need to evaluate if this requires change to other requirements to implement
