SUBJECT: LICENSE AMENDMENT

Dear Dr. Childs:

Please find enclosed Amendment Number 70 to NRC License Number 25-00326-06 changing the Radiation Safety Committee (RSC) Chairperson on your license and adding a storage/use location, as requested in letters dated October 2, 2018 and December 20, 2018, respectively. You also provided additional information about your custom built dry waste compactor and dry waste compaction program. An additional technical review is needed to authorize this activity. An environmental assessment for this licensing action is not required since this action is categorically excluded under 10 CFR 51.22(c)(14)(v). You should review this license carefully and be sure that you understand all conditions. You can contact me at 817-200-1127 if you have any questions about this license.

The NRC's Safety Culture Policy Statement became effective in June 2011. The signatory for the application should be the licensee or certifying official rather than a consultant. Since the NRC also

accepts a letter requesting amendment of an NRC license, the signatory for such a request should also be the licensee or certifying official rather than a consultant.

NRC will periodically inspect your radiation safety program. Failure to conduct your program according to NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC may result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
