Dear Peter Habighorst:

Ecology requests a representative from your Branch to attend an Ecology-sponsored public meeting in March 2019. Ecology wants an NRC representative to be available to answer any questions about the NRC licensing of imports and exports of international waste processed at the PermaFix Northwest (PFNW) facility in Richland, Washington.

The purpose of the public meeting is to collect comments on the scope of a State Environmental Policy Act (SEPA) evaluation of PFWN. Ecology is renewing a state Dangerous Waste Regulations (DWR) permit for the PFWN mixed waste operations. Ecology's DWR implement an EPA-authorized state hazardous waste program. SEPA regulations require Ecology to analyze the potential adverse environmental impacts of Ecology's action of issuing the permit.

Ecology will not be issuing a DWR permit for the Low-Level Waste operations at PFWN that are licensed by the Washington Department of Health. Ecology's SEPA regulations require us to analyze the potential adverse environmental impacts of those LLW operations because they could contribute to the cumulative impacts of PFWN. Ecology will be evaluating the potential impacts of international waste brought to PFWN as LLW. Therefore, Ecology will be distributing information to the public about the NRC import/export licensing process.




