NEIL also provides excess and blanket nuclear property insurance. The Company's total nuclear property insurance coverage is \$50 million for Kewaunee Power Station, \$1,700 million for Millstone Power Station, \$1,700 million for North Anna Power Station and \$1,700 million for Surry Power Station.
