Subject: St. Lucie Plant Unit Nos. 1 and 2 - Acceptance for Review of License Amendment Request Regarding Emergency Diesel Generator Surveillance Requirements (EPID L-2018-LLA-0574)

By letter dated December 20, 2018 (Agencywide Documents Access and Management System Accession No. ML18354A901), Florida Power & Light Company (the licensee) requested amendments to the Technical Specifications (TSs) appended to Renewed Facility Operating License No. DPR-67 for St. Lucie Plant, Unit No. 1 and Renewed Facility Operating License No. NPF-16 for St. Lucie Plant, Unit No. 2. The U.S. Nuclear Regulatory Commission (NRC) staff performs acceptance reviews of applications to determine if the scope and depth of technical information is sufficient for the staff to complete its technical reviews. The acceptance reviews also intend to identify whether applications have any readily apparent information insufficiencies in the characterization of the regulatory requirements or the licensing basis of the plant.

Consistent with Section 50.90 of Title 10 of the Code of Federal Regulations (10 CFR), an amendment to the license (including the TSs) must fully describe the changes requested, and following as far as applicable, the form prescribed for the original application. Section 50.34 of 10 CFR addresses the content of technical information required. This section stipulates that the submittal address the design and operating characteristics, unusual or novel design features, and principal safety considerations.

The NRC staff has reviewed the licensee's submittal and concluded that it provides technical information in sufficient detail to enable the staff to complete its detailed technical review and make an independent assessment regarding the acceptability of the proposed request in terms of regulatory requirements and the protection of public health and safety and the environment. Given the lesser scope and depth of the acceptance review as compared to the detailed technical review, there may be instances in which the NRC staff identifies issues that affect its ability to complete the detailed technical review despite completion of an adequate acceptance review. If the NRC staff needs additional information, it will notify the licensee by separate correspondence.

The staff has estimated that it will take approximately 400 hours to complete its review of this licensing request and that it will complete its review within one year of submittal of the application (i.e., by December 2019) as requested by the licensee. These estimates are based on the NRC staff's initial review of the application and could change because of several factors, such as requests for additional information, unanticipated addition of application scope, review by NRC advisory committees, or hearing related activities. Additional delay may occur if the submittal is provided to the NRC in advance of or in parallel with industry program initiatives or pilot applications. If complexities or challenges during the review cause significant changes to the estimated hours or completion date, the assigned project manager will communicate the new estimates and reasons for the changes to the licensee during routine interactions.
