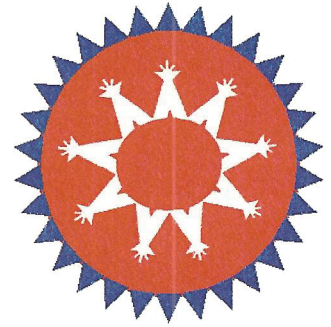

The Oglala Sioux Tribe has been informed that you have taken the responsibility as the lead project manager for the NRC Staff's review and consideration of the licensing process for the proposed Dewey-Burdock in-situ leach uranium mine, and Ms. Jean Trefethen as a new NRC Staff member assigned to the matter. Further, the Oglala Sioux Tribe has been informed that NRC Staff has selected Mr. Jerry Spangler as a replacement for Dr. Paul Nickens.

The Oglala Sioux Tribe is eager to discuss the survey methodology and elder interview protocols, among other aspects of the project, with Mr. Spangler and NRC Staff. To this end, a meeting of the Oglala Sioux Tribe's Tribal Historic Preservation Advisory Council has been set for February 22, 2019 at the Oglala Lakota College He Sapa College Center in Rapid City, SD. The Oglala Sioux Tribe would like to extend to you and Mr. Spangler, and other NRC Staff as you find appropriate, to attend the meeting. The Oglala Sioux Tribe has also invited some of its cultural resources experts to attend to help identify the expertise available and what expertise may still be needed, and to further discussions between the parties.

The Oglala Sioux Tribe Cultural Affairs and Historic Preservation Office encourages NRC Staff to reach out in advance of the February 22, 2019 meeting to begin the conversation and to identify topics for discussion in-person. In particular, the Oglala Sioux Tribe is interested in NRC Staff's substantive comments and response to the Oglala Sioux Tribe's January 11, 2018 response to the NRC Staff's November 21, 2018 letter, including NRC Staff's input on the previously identified cultural survey methodologies.

Please confirm NRC Staff's and Mr. Spangler's attendance for February 22, 2019 and the Oglala Sioux Tribe looks forward to hearing from you.
