


MATERIALS LICENSE

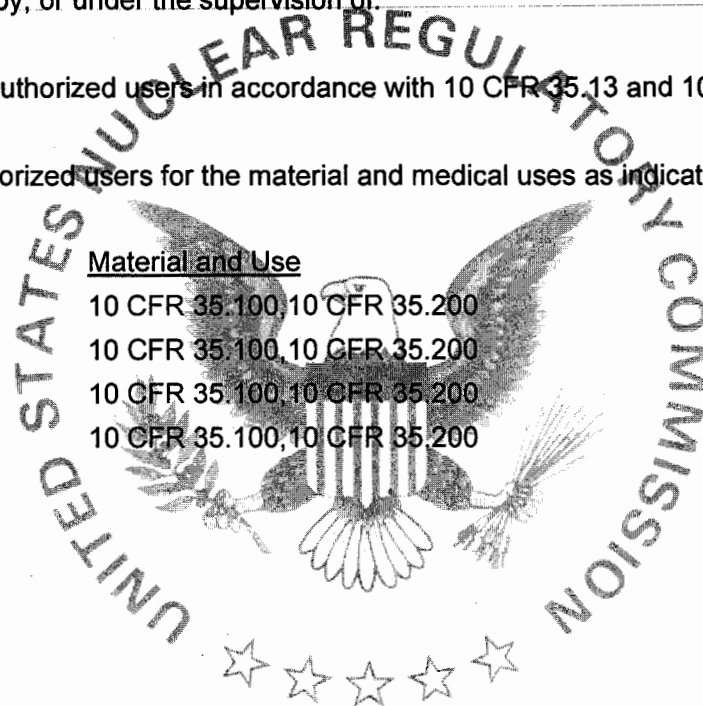
