This refers to your license amendment request dated December 11, 2018. Please find enclosed Amendment No. 5 authorizing the new location of use at 1351 Washington Boulevard, Stamford, Connecticut and releasing the previous location of use at 733 Summer Street, Suite 506, Stamford, Connecticut.

The facility located at 733 Summers Street, Suite 506 may be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14) and 10 CFR 51.22(c)(20).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
