This refers to your license amendment request dated December 17, 2018. Please find enclosed Amendment No. 12 naming John J. Staab, III as the Radiation Safety Officer and removing the facility at 124 Richardson Road, Hardwick, Vermont as a location of use.

The facility located at 124 Richardson Road, Hardwick, Vermont may be release for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14) and 10 CFR 51.22(c)(20).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
