(System One), in response to the U.S. Nuclear Regulatory Commission (NRC) notice of violation (NOV) that was discussed in the subject U.S. NRC investigation report (IR).

We have reviewed your letter and find that it is responsive to the NOV documented in IR 3-2017-003. As requested in your response, we have revised the Factual Summary to reflect the legal name of System One in the Agencywide Document Access and Management System, Accession No. ML18208A314. The NRC also considered the additional information provided in your response and determined that no additional changes were warranted because there were no actual contradictions to the Factual Summary presented.
