Mr. Hopson-

I am emailing you to inform you that the Nuclear Regulatory Commission's Petition Review Board has made an initial recommendation to reject the 2.206 Petition filed by Greenaction for Health and Environmental Justice to revoke Tetra Tech's License. The basis for this initial rejection was based on the criteria in Management Directive (MD) 8.11, "Review Process for 10 CFR 2.206 Petitions", to reject the Petition based on the failure of the Petition to present new significant information.

On Friday, February 24, 2019, we contacted the Petitioner's attorneys, Mr. Anton and Mr. Castleman, for Greenaction for Health and Environmental Justice to notify them of this initial rejection and have requested to have a second opportunity to address the PRB as is allowed on page 14 of MD 8.11 and have preliminarily chosen to have the discussion in a Public Meeting to be held at the NRC Headquarters in Rockville, MD. Currently, the Petitioner's attorneys are looking for a convenient date for this meeting.

As part of the process, you, the licensee, will also be allowed to address the PRB, and as such, we are asking that you review your calendar and provide dates that are convenient as well. Although the Petitioner has chosen to seek a meeting in person with the PRB, you have the opportunity to not participate, to participate by phone, or participate in person.
