This refers to your license amendment request dated January 14, 2019. Please find enclosed Amendment No. 2 adding 1417 Marshall Avenue, Williston, Vermont as a new location of use. Your current facilities, located at 200 Commerce Street, Williston, Vermont, will remain on your license until such time you submit a request to remove the location once all decommissioning activities have been completed.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
