### **Definitions:**

1. The new licensee name will be Mosaic Medical Center - Maryville. The RSO and staff within the nuclear department will remain the same. There will be changes to the board of directors to include representation from Mosaic Life Care, St. Joseph, MO.

2. There will no changes in personnel or duties to the licensed program. There will be no changes to the training program related to the licensed program. Site specific training is provided for all workers. Occupational workers (i.e., Nuclear medicine technologists) will receive initial and annual radiation safety training. Ancillary or non-occupational workers (e.g., nursing, clerical, housekeeping, security) whose duties may require them to work in the vicinity of radioactive material (whether escorted or not) will be informed about radiation hazards and appropriate precautions. All training will be tailored to meet the needs of the individual's in attendance. The extent of instruction will be commensurate with the potential radiological hazards associated with the individual's job. Please refer to Section 5 of our policy and procedure manual.

3. There will be no change to the location, facilities, equipment and radiation safety program, use, possession, waste management or other procedures that relate the licensed program. Licensed material will continue to be used and stored at the licensee facility located at 2016 S. Main St., Maryville, MO. 64468, as stated in License conditions item 10 of our Radioactive materials license #24-26415-01. We will continue to conduct our program in accordance with statements, representations, policy and procedures contained in the documents and as required under our current license.

4. The current status of the facility is operational. There are no known issues to the facility at this time. All equipment has been maintained and quality control testing performed as required. All equipment is operating well within manufacturers recommended parameters. There will be no changes to the current Radiation Safety program, practices, or Radiation Safety Officer. All equipment calibrations, sealed source inventories, sealed source leak tests certificates are current and up-to-date at this time. All area surveys, wipe test, training quality control and other related records are current and up-to-date at this time. A contracted health physics group performs items mentioned on a consistent frequency. All certificates are reviewed and signed by the RSO prior to being filed in the designated sections of our records manual. All records are available upon request. The management of Mosaic Medical Center-Maryville are committed to the Radiation Safety Program as described in section 9 of our policy and procedure manual for keeping individual and collective doses as low as reasonably achievable (ALARA).

In accordance with this commitment, we have an administrative organization for radiation safety and have/will develop the necessary written policy, procedures and instructions to foster the ALARA concept within our institution. The organization currently includes a Radiation Safety Committee (RSC) and a Radiation Safety Officer (RSO).

6. There will be no changes in operations or duties that relate to the licensed program. Therefore, there will not be a decommissioning of the facility at this time.

7. Confirmation that both transferor and transferee agree to transferring control of the licensed material and activity, and the conditions of transfer, and that the transferee has been made aware of any open inspection items and its responsibility for possible resulting enforcement actions are confirmed through the signing of this document by both parties.
