Discussion: I contacted Mr. Luis Burgos Valdespino to schedule a pre-licensing visit to review Southwest Construction Group's preparations for a change-of-control of the portable gauge license from Desarrolladora J.A., Inc. to Southwest Construction Group.

Mr. Burgos Valdespino reported that he has not yet constructed a storage area and his preparations are on-hold until he is able to secure construction contracts for work. Mr. Burgos Valdespino stated that he will notify NRC once he makes a decision to proceed. I informed Mr. Burgos Valdespino that if the change-of-control action is not completed by July 2019, then the amendment request will be voided.
