
As the Governor-appointed State Liaison Officer, Mr. Emme will also function as my state employee representative, as provided for in Part 73.59(e) of your regulations, for receipt of Safeguards Information (SGI) and Safeguards Information-Modified Handling (SGI-M) that may be transmitted by the NRC. Mr. Emme has been informed of the protection requirements for SGI and SGI-M and will establish the controls necessary to maintain compliance with Parts 73.21 through 73.23 of your regulations. His agency possesses the necessary physical protection resources for properly storing SGI and SGI-M.
