Refueling Outage U1R38 Owner's Activity Report for Class 1, 2, 3 and MC ISI Examinations

NextEra Energy Point Beach, LLC (NextEra) is submitting inservice inspection summary reports for inspections conducted prior to and during the Point Beach Nuclear Plant (PBNP) refueling outage U1R38 that concluded on April 19, 2019.
