On October 19, 1976 we informed you of a situation concerning the TMI-1 River Water Pumps. A review of the column flange design revealed that the manufacturer's stress calculations may not have properly accounted for both flange bolting forces and seismic forces.

Since then, tests have been performed by the manufacturer. The results of these tests have confirmed the seismic acceptability of these pumps.
