Dear Mr. Hart:

Enclosed is Amendment No. 02 to your NRC Materials License No. 21-32838-02 in accordance with your request. Please note that your license format has been changed based on our new Web-based Licensing (WBL) system. In addition, we have updated the following License Conditions in accordance with our policy: Condition No. 10 regarding NRC jurisdictions at temporary jobsites, Condition No. 11 regarding the record retention for gauge users, Condition No. 13 regarding the sealed source leak test requirements, Condition No. 15 regarding the physical inventory requirements, and Condition No. 17 regarding the security of portable gauges. We deleted Condition No. 20 regarding the transportation requirement listed in your previous license amendment. Please note that the requirements for two physical security barriers for portable gauges and transportation are in 10 CFR 30.34(i) and 10 CFR part 71, respectively.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
