Good afternoon,

In the letter, you need to specify the application that you are submitting for renewal. The application that the staff has in house has additional contents that are not approved for transport in revision 2 of the CoC. Therefore, the review of the application in house will need to finish at the same time or before the renewal is issued.

You should look at the latest revision of the CoC No. 9355 and see the application referenced in that CoC as well as the supplements listed in the "REFERENCES" section. (Also, please delete docket No. 9250, which is incorrect. The docket No. for the 435-B is 71-9355.) I am attaching an example of a letter requesting a renewal with no changes to the SAR (application) and referencing the appropriate revision of the CoC, including the expiration date.
