SUBJECT: SUMMARY OF JULY 24, 2019, OPEN CATEGORY 2 AND
CLOSED MEETING WITH THE U.S. NUCLEAR REGULATORY
COMMISSION STAFF AND OKLO, INC., TO DISCUSS OKLO,
INC. PHYSICAL SECURITY AND EMERGENCY
PREPAREDNESS (EPID LRM-0011)

On July 24, 2019, a meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and representatives from Oklo, Inc. (Oklo) at the NRC offices at One White Flint North, 11555 Rockville Pike., Rockville, Maryland 20852, Room 2-H50. The meeting was a combination of a public Category 2 and non-public meeting. The purpose of the meeting was to discuss Oklo's plans for emergency preparedness (EP) and physical security.

The public portion of the meeting commenced with an introduction to Oklo and its organization. Oklo also provided information on its design, including key design features, size, fuel, and safety case and its impacts on physical security and EP. Oklo also presented results from its implementation of Draft Guide (DG)-1353, "Guidance for a Technology-Inclusive, Risk-Informed, and Performance-Based Approach to Inform the Content Applications for Licenses, Certifications, and Approvals for Non-Light Water Reactors," including the proposed application content in the areas of physical security and EP.

To conclude the public portion of the meeting, the NRC staff committed to actively supporting Oklo in additional pre-application interactions, including requests for NRC actions and participation in public meetings, to better enable preparation for a custom combined license application that may require the consideration of unique approaches to technical analyses and regulatory requirements. As part of this discussion, the NRC staff suggested that the NRC staff and Oklo plan future discussions on the identification of applicable regulations, including potential exemptions, and the safety case for Oklo's proposed facility and application. The NRC staff stated that coordination on more detailed technical discussions on design-specific information would be key to successful pre-application discussions. Specifically, the NRC staff requested that future meetings with Oklo cover 1) the Oklo safety case, including design basis accidents, site considerations, and the establishment of emergency planning zone and 2) a discussion on how Oklo would either meet existing regulations or request exemptions. Oklo agreed that these discussions would be beneficial and would work with the NRC staff to arrange these meetings.

During the non-public portion of the meeting, Oklo sought NRC staff feedback on Section 15, "Emergency Plans," and Section 28, "Physical Security," of the Oklo "DG-1353 Pilot Report." During these discussions, the NRC staff provided its views on physical security and EP for a micro-reactor design. As a result of these discussions, the NRC staff gained insight on the maturity of Oklo's safety case and plans for physical security and EP. The NRC staff suggested that future discussions on these topics would be beneficial to prepare for an application submittal.
