NRC Comment

Paragraph 3 of page 2 of your letter number 731, dated January 7, 1979, in response to the Notice of Violation dated December 12, 1978, states that the procedure to assure corrective action regarding posting of changes to controlled drawings should be approved by February 1, 1979.

Contrary to the above, station administrative procedure ADM-43.31 was not approved by the Station Manager until March 5, 1979.

A similar item was brought to your attention in our letter dated November 21, 1979, for Unit 1.

Response

The above deviation is correct as stated.

Specifically, pursuant to section 2.201 of the NRC's "Rules of Practice" Part 2, Title 10, Code of Federal Regulations, the following information is submitted:

1. Corrective steps taken and results achieved:

We reviewed our commitment tracking program and determined it did not incorporate the specific commitment of each item listed. The program was then restructured to include a specific statement of commitment. A printout, of all the open items being tracked, is now being made available for station management review on a periodic basis.

2. Corrective action taken to avoid further deviation:

The commitment tracking program is being updated and an open items printout is being distributed periodically.

3. Date when full compliance will be achieved:

As stated, ADM-43.31 was approved March 5, 1979. The commitment tracking program was restructured and implemented on May 25, 1979.
