SUBJECT: INVITATION FOR TELECONFERENCE AND CONTINUED CONSULTATION
REGARDING THE DEWEY-BURDOCK IN SITU URANIUM RECOVERY
PROJECT (DOCKET NUMBER: 40-9075)

Dear Ms. Lone Hill:

The U.S. Nuclear Regulatory Commission (NRC) staff met with you and other representatives of the Oglala Sioux Tribe on May 19, 2016, in Pine Ridge, South Dakota. During this meeting, the Oglala Sioux Tribe shared their concerns regarding the surveys conducted at Powertech (USA) Inc.'s Dewey-Burdock Project site to identify historic and cultural resources, the lack of meaningful opportunities in the Dewey-Burdock Programmatic Agreement (PA) for Tribes to provide input about the management of these resources, and the continued effectiveness of the license in light of the Atomic and Safety Licensing Board (ASLB's) April 30, 2015 decision. The Oglala Sioux Tribe also requested that the NRC staff take into account Tribal Treaties, laws and ordinances prohibiting nuclear activities within Treaty lands.

During a teleconference held on November 7, 2016 with the ASLB and parties in the Dewey-Burdock proceeding, counsel for the Oglala Sioux Tribe noted that the Oglala Sioux Tribe was awaiting the NRC staff's response to the suggestions raised by the Oglala Sioux Tribe in the May 19, 2016 meeting. Therefore, in this letter, the NRC staff addresses the Oglala Sioux Tribe's objection to the continued effectiveness of the license and the Oglala Sioux Tribe's request that the NRC staff take into account Tribal Treaties, laws and ordinances prohibiting nuclear activities within Treaty lands. The NRC staff invites the Oglala Sioux Tribe to meet with the staff to discuss the parameters of an additional survey of the Dewey-Burdock site and the Oglala Sioux Tribe's recommendations regarding the Dewey-Burdock PA.

With respect to the license for the Dewey-Burdock Project, the NRC staff does not currently believe that circumstances require staying the effectiveness of the license. The licensee has not begun construction activities, and it has not obtained permits from the U.S. Environmental Protection Agency and the State of South Dakota that are required before the licensee could commence construction and operation of the Dewey-Burdock Project.

With respect to the Oglala Sioux Tribe's request that the NRC staff take into account Tribal Treaties, laws and ordinances prohibiting nuclear activities within Treaty lands, the NRC staff reiterates its willingness to consider these laws and ordinances as part of the consultation process. During the May 19, 2016 meeting, the Oglala Sioux Tribe offered to provide to the NRC staff the references to these laws and ordinances. Therefore, at your convenience, we

The NRC staff would like to arrange a meeting to further consult with the Oglala Sioux Tribe regarding the parameters of an additional survey of the Dewey-Burdock site and the Oglala Sioux Tribe's recommendations regarding the Dewey-Burdock PA. The NRC staff proposes to hold this meeting via a teleconference call, which the staff envisions would be approximately two hours in duration. The NRC staff proposes a date during the weeks of December 12, 2016, December 19, 2016, or January 9, 2017, for this teleconference. We request that you respond with a preferred date and time for a teleconference during this timeframe. If this suggested timeframe is not agreeable, we request that you respond within 30 days of receipt of this letter with an alternate date and time that is suitable for your schedule.
