Pursuant to the Freedom of Information Act and applicable regulations, I hereby request that copies of the following documents be made available within the period specified in the Freedom of Information Act:


All documents, including but not limited to letters, memoranda and minutes of meetings and telephone conversations, referring to or relating to investigation report No. 50-244/74-01.
