Dear Mr. Witt:

This refers to your license amendment request dated March 15, 2019. Please find enclosed Amendment No. 5 authorizing a license name change. Your March 15, 2019, license renewal application also requested NRC to change your license name. At that time, it was not clear to us if your request represented a simple name change or a transfer of license control. As a result, we renewed your license and opened-up a separate action dated June 10, 2019, to determine if your request represented a transfer of control action. Our review determined that the transfer of control was previously approved by NRC in 2014, and, as you indicated, this amendment represents a name change only.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
