While in a cold condition, during the conduct of Operations Surveillance Test F-ST-11 titled "Off Gas Process Radiation Monitor Instrument Functional Test," to satisfy the requirements of Technical Specification Appendix A, Paragraph 4.2.D.2, the recorder (17-RR-152) did not correspond to the reading indicated on the channel "A" Radiation Monitor.

The redundant instrument (Channel B Monitor) was verified operable, therefore the event did not represent any significant hazard to the public health and safety.

The recorder was recalibrated and proper operation was verified by successful completion of F-ST-11.
