

This will be based on a consultant's optimization study. CP&L would like to meet with NRC to discuss this program and necessary technical specification changes at appropriate time. CP&L's new submittal should be assigned a high priority at NRC.

8/14/78	Plant Reorganization	Suspended	Superceded by updated 8/14/79 submittal.
