1 1 | move near the drop line that connected the trap to the 500 KV line. Because

1 2 | the drop line had several loose strands, arcing occurred whenever the line was

1 3 | near the trap. The cable was repaired and both the cable and the current trap

1 4 inspected and returned to service.
