I live and work less than 50mi from the proposed plant The Allens Creek Nuclear Power project, which will be a constant threat to our health and lives so long as it exists. Regular and accidental discharge of radioactive poisons can be much larger than permissible under Federal Regulations, not counting a major accident near a major population center.

Contentions

I contend that the Allens Creek facility can't meet the NRC Reg concerning reactor siting # 10CFR part 100 - other reasons 10CFR 100.11. Because it's too close to a major population center 10CFR part 50, App E can't be met.

City of Houston doesn't evacuation plan

- The proposed plant don't meet 10CFR part 50 App I, because it will emit 36,000 curies/year of radiation yet the Black Fox station of similar design and size will emit only 7,000 curies. Therefore "Allens Creek" radiation emissions not as low as possible.
