This letter documents the Nuclear Regulatory Commission (NRC) staff's plan to perform an inspection of ENSA Equipos Nucleares' S.A., S.M.E (ENSA) Appendix B, "Quality Assurance Program Criteria for Nuclear Power Plants and Fuel Reprocessing Plants," to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 50, "Domestic Licensing of Production and Utilization Facilities" quality assurance and 10 CFR Part 21, "Reporting of Defects and Noncompliance," programs as they pertain to activities conducted at your facility related to the commercial grade dedication program associated with nuclear-related parts for NRC's regulated facilities. As discussed via electronic mail on July 1, 2019, the NRC inspection team plans to arrive at your facility on Monday, October 21, 2019, and will conduct an inspection through Friday, October 25, 2019.
