This refers to the inspection conducted from August 19 – 22, 2019, at your Mt. Athos facility located in Lynchburg, VA. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely, and in accordance with the Nuclear Regulatory Commission (NRC) requirements. At the end of the inspection, the findings were discussed with you and members of your staff.

Areas examined during the inspection consisted access control measures for personnel, material, and vehicles into the owner-controlled areas, protected area, material access areas, and storage vaults; and your program for protecting classified national security information and restricted data. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations of activities in progress.

The enclosed inspection report contains Security-Related Information in accordance with 10 CFR 2.390(d)(1) and its disclosure to unauthorized individuals could present a security vulnerability. Therefore, the material in the enclosure will not be made available electronically for public inspection in the NRC Public Document Room or from the NRC's document system (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
