Issues:

1. Note that the Part 37 license condition modification listed in 2013-1 has been approved. The two Rules not listed in the license condition 30.13 (Carrier exemption) and 71.97 (Advance Notification) are included in Rule 64E-5.102 (carrier exemption) and 64E-5.1506(2) which is part of the RATS 2012-2 Advance Notice to Native American Tribes of Transportation of Certain Types of Nuclear Waste. This completes the missing non-Part 37 portions of RATS 2013-1.
2. RATS 2015-5 Definition of "Indian Tribe" is included in Rule 64E-5.101 and as well as the revision to 71.97(c)(3)(ii) Advance Notification of shipment of irradiated reactor fuel and nuclear waste" is included and updates the text of RATS 2012-2 is listed in Rule 64E-5.1506. This completes the missing transportation portions of RATS 2015-5.
3. Part 71 Compatibility Table dated 4/25/2018 was used to adopt and incorporated by reference the applicable sections of 10 CFR Part 71 printed edition dated 1/1/2019. The RATS 2015-3 table (7/13/2015) was submitted for completion only since its listings are included. Not included are the multiple 49 CFR Parts incorporated by reference. They are available via hyperlinks in the draft rule text.
