The purpose of this contract modification is to: 1) exercise option year one in accordance with FAR Clause 52.217-9, OPTION TO EXTEND THE TERM OF THE CONTRACT, thereby extending the period of performance through September 27, 2020 and increasing the contract ceiling by [REDACTED] from [REDACTED] to [REDACTED]; and 2) provide incremental funding in the amount of \$800.00 to partially fund the Firm Fixed Price portion of option year 1, thereby increasing the funding \$240,000.00 to \$240,800.00. Accordingly, the contract is hereby modified as follows:

- 1) Section **B.2 CONSIDERATION AND OBLIGATION— FIRM-FIXED-PRICE** is deleted in its entirety and replaced with the following:

“The total amount of the Firm-Fixed-Price portion of this contract is [REDACTED] and [REDACTED] of this amount is funded which fully funds the base year and partially funds Option Year 1 of the contract.”

- 2) Section **B.3 CONSIDERATION AND OBLIGATION – TIME-AND-MATERIALS CONTRACT (AUG 2011)** is deleted in its entirety and replaced with the following:

“(a) The ceiling price to the Government for full performance under this contract is **\$997,016.20**.

(b) The contract includes: Firm-Fixed Price line items totaling [REDACTED] and (2) direct labor hours at specified fixed hourly rates, inclusive of wages, fringe, overhead, general and administrative expenses, and profit, totaling [REDACTED]

(c) Total estimated cost for the Base Period (Exercised) and Option Year 1(Exercised) is [REDACTED]

(d) The amount presently obligated by the Government with respect to this contract is **\$240,800.00**.

(e) It is estimated that the amount currently obligated will cover performance through **04/29/2020**.

(f) This is an incrementally-funded contract and FAR 52.232-22 – “Limitation of Funds” applies.

- 3) Section **F.2 PERIOD OF PERFORMANCE ALTERNATE III** is deleted in its entirety and replaced with the following:

“This contract shall commence on **September 28, 2018** and will expire on **September 27, 2020**. The term of this contract may be extended at the option of the Government for an additional one (1) 1-year option period, with an ultimate completion date of **September 27, 2021** for a total of three (3) years.

The term of this contract may be extended at the option of the Government for an additional **six (6) months**.
