This refers to your license amendment request dated August 27, 2019. Please find enclosed Amendment No. 10 authorizing a change in your mailing address as used above. The NRC was not able to approve your request for a change in storage locations because both locations of storage are under the regulatory authority of the Commonwealth of Pennsylvania and not the NRC. It is our understanding from our telephone discussion on September 9, 2019, that you have submitted an amendment request for the change of storage locations with the Commonwealth of Pennsylvania.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy. 
