By letter dated June 28, 2019, Michigan Cardiology, P.C. submitted to the U.S. Nuclear Regulatory Commission (NRC) a request for consent to a direct license transfer of NRC Materials License No. 21-32110-01 pursuant to a purchase agreement with Heart Rhythm Clinic of Michigan. The letter is available electronically from the NRC's Agencywide Documents Access and Management System (ADAMS) at Accession Nos. ML19192A259 and ML19213A116. Based on the information provided, Heart Rhythm Clinic of Michigan became the owner of Michigan Cardiology, P.C. Further, we understand that this transfer will not result in any change to the licensed materials, locations of use of licensed material, or the Radiation Safety Officer responsible for the oversight of the licensee's radiation safety program.

Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, we have no objection to the transfer of License No. 21-32110-01.


