Subject: KRANISH FOIA APPEAL 79-A-3

Purpose: To propose a letter from the Secretary denying this appeal.

Discussion: In FOIA 78-318 Mr. Kranish requested the transcript of the Commission's meeting of November 6, 1978, at which the EDO Testimony of 1977 was discussed (Attachment 1). The initial response to Mr. Kranish indicated that the transcript would be placed in the PDR minus deletions made for classified material (Attachment 2). The total deletions were approximately 27 lines from a 70-page transcript (Attachment 3).

By letter to the Secretary dated March 9, 1979, Mr. Kranish has appealed the deletions (Attachment 4). A classified copy of the transcript with deleted portions marked is being transmitted by SECY to the Commissioners and OPE.

The proposed letter to Mr. Kranish (Attachment 5) denies the appeal, stating that the deleted portions are properly classified and are withheld from public disclosure


