Dear Mr. Patterson:

By letter dated January 4, 2019 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML19008A046), Honeywell submitted its triennial decommissioning funding plan (DFP) update for the Metropolis Works facility to the U.S. Nuclear Regulatory Commission (NRC) as per License Condition 25 and Title 10 of the *Code of Federal Regulations* (10 CFR) Section 40.36(d) for staff review and approval. On April 24, 2019 (ADAMS Accession No. ML19101A139), as part of the acceptance review, the staff sent a request for supplemental information (RSI) regarding the DFP. Honeywell provided its response to the RSI on July 16, 2019 (ADAMS Accession No. ML19200A031). The NRC notified Honeywell on August 13, 2019, that the DFP had been accepted for review (ADAMS Accession No. ML19225C757). The NRC staff has reviewed Honeywell's DFP and supplement and has identified that additional information is needed in order to complete the evaluation.

Your response to the requests for additional information, as specified in the enclosure, should be provided to the NRC within 60 days from the date of this letter.

In accordance with 10 CFR, Section 2.390, of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records System component of the NRC's ADAMS.
