**Purpose of the Meeting:** To provide an opportunity for the NRC and external stakeholders to exchange information on the impact of the Alternatives to Credit Ratings proposed rule.

**General Details:** The meeting was attended by 14 NRC staff and 12 members of the public.

**Summary of NRC Presentation:** The NRC staff presented an analysis of the Dodd-Frank Wall Street Reform and Consumer Protection Act of 2010 (Dodd-Frank Act) and its impact on the NRC regulations. The staff also discussed the alternatives for implementing the requirements of the Dodd-Frank Act, the staff's recommendation for a proposed rulemaking, and the rulemaking timeline for the proposed rule.

**Summary of Public Feedback:** Participants, including representatives from the Nuclear Energy Institute, the law firm Morgan, Lewis & Bockius, Florida Power and Light Company, and Exelon, provided remarks on the industry's views on the proposed rule. The consensus of the views shared by meeting participants is that a proposed rule which relies on existing financial tests would have a substantial financial impact on the industry. In addition, participants recommended the NRC examine what approaches other agencies have taken to implement the Dodd-Frank Act requirements and use this information to help identify new financial tests for providing financial assurance of decommissioning funds that do not expose the industry to excessive financial burden.

#### **Action Items/Next Steps:**

The staff will consider, to the extent possible, public feedback received to inform the development of the proposed rule and associated guidance.
