Dear Mr. Welsch:

This refers to an investigation conducted by the U.S. Nuclear Regulatory Commission's (NRC's) Office of Investigations regarding activities at the Diablo Canyon Power Plant. The Office of Investigations initiated the investigation to determine whether a security supervisor at the Diablo Canyon Power Plant willfully failed to report an inattentive security officer.

Based on the evidence developed during the investigation, this concern was not substantiated. The NRC plans no further action related to the willful aspect of this allegation and considers this investigation closed.
