A study by the Texas Commission on Environmental Quality showed that this site is not ideal for disposal of radioactive waste because of risk of water contamination. This rule change seems designed to allow inadequate disposal of this waste through shallow burial.

Furthermore, the risk of transport of GTCC waste across the country has not been adequately accounted for. Numerous communities would be put at risk as this dangerous waste passes through them.

I urge you not to proceed with this rulemaking and to develop a safe solution for the handling and disposal of Greater-than-Class C waste.
