Dear Ms. Amstutz:

As you may be aware, the U.S. Nuclear Regulatory Commission (NRC) previously communicated to FMRI via letter dated February 25, 2017 (Agencywide Documents Access and Management System [ADAMS] Accession Number ML17038A313) that the NRC agreed to authorize the Trust to pay outstanding and upcoming invoices for transportation and reclamation of the stockpiled work in progress (WIP) materials. This commitment was made even though the Forbearance Agreement dated September 2015 had expired and not been renewed. By letter dated December 2, 2019 (ADAMS Accession Number ML19353A471), FMRI requested that the amount of \$23,924.20, be disbursed to Energy Fuels Resources (EFR) to pay invoice number FMRI-103117. This invoice is for reclamation of material received and processed by EFR in 2017. It is the NRC's understanding that the invoice is dated September 15, 2019 because of administrative errors at EFR resulting in a delay in invoicing.

FMRI requested that the amount of \$23,924.20 associated with the EFR, Inc. invoice number FMRI-103117 be paid to:

The NRC has reviewed the invoice, information, and certification provided by FMRI. Based upon the information provided, the NRC has confirmed the amount for the invoice from EFR. An amount equal to \$23,924.20 is associated with processing of WIP materials in 10 intermodals. Therefore, consistent with the FMRI Decommissioning Trust and the NRC's February 25, 2017 letter, a check for \$23,924.20 can be issued to EFR as indicated above.
