SUBJECT Additional Information Needed for License Amendment					
SUMMARY <p>As requested in my letter dated November 15, 2019, I requested that you resubmit your request on company letterhead having the request signed by a management representative. I explained that this was necessary because the license is a legal document and all correspondence with this office must be signed and dated by individuals that are authorized by your company to make legally binding statements. I did advise that in lieu of a signed letter, I could also accept the request provided that an attached Delegation of Authority, signed by a management representative, which supported your appointment as Radiation Safety Officer was provided. You agreed to resubmit the request in proper form as requested.</p> <p>I also requested clarification of your intention with regards to the submission of the Radiation Protection Program. I alerted you that the evaluation of the Radiation Protection Program would delay the amendment request because I would need to ensure that your updated program was either consistent with our NUREG-1556, Volume 1, or otherwise satisfied the minimum regulatory requirements. You advised that submission of the Radiation Protection Program was done in error and that it should be rescinded. The only portion applicable was the RSO Duties, which you indicated would be resubmitted with you response letter. If desired, I advised that you could revise and resubmit your Radiation Protection Program at any time, but I recommended making this a separate request.</p> <p><b>Continue on Page 2</b></p>
