By letter dated September 9, 2019 (Agencywide Documents Access and Management System Accession No. ML19253A107), Westinghouse Electric Company (Westinghouse) submitted to U.S. Nuclear Regulatory Commission (NRC) request to modify safety evaluation report for the previously approved WCAP-12472-P-A, "BEACON™ Core Monitoring and Operations Support System."
