SPECIAL APPEARANCE OF WESTINGHOUSE ELECTRIC CORPORATION

Westinghouse Electric Corporation (Westinghouse) is making a special appearance in this proceeding for the sole purpose of ensuring the confidential treatment of proprietary information owned by Westinghouse and supplied to this Commission by the Licensee, Wisconsin Electric Power Company.<sup>1/</sup>

Protection from public disclosure by the Commission's staff, as envisioned by 10 CFR Part 9 (1981), has been applied for pursuant to 10 CFR §2.790 (1981). In any event, in view of the Licensing Board's intention to address this question and decide whether or not the proprietary claims should be upheld by the Board (Tr. 438-39), Westinghouse desires an opportunity to participate in any proceedings conducted by the Board to that end.
