Gentlemen:

Attached is License Change Application # 5 requesting amendment of Operating License NPF-82 for the Shoreham Nuclear Power Station (SNPS). This amendment application, conforming to the guidance of Generic Letter 89-01 (reference 1), is made to simplify the full power Technical Specifications (NUREG-1357, April 1989, as amended) that the Long Island Lighting Company (LILCO) presently holds for SNPS. Approval by the Commission's Staff of LILCO's previously submitted license amendment request (reference 2) for the removal of operating authority would make this Generic Letter 89-01 license amendment moot. However, inasmuch as the review and approval schedule for the January 5, 1990 (reference 2) license amendment is indeterminable at this time, it behooves LILCO to take advantage of the immediate relief offered by Generic Letter 89-01. Therefore, this submittal is made for the NRC's review.


