
By letter dated October 16, 2019 (Agencywide Documents Access and Management System [ADAMS] Accession Number ML19290E196), you requested that the U.S. Nuclear Regulatory Commission (NRC) terminate Special Nuclear Materials License Number 2016 (SNM-2016) for Passport Systems, Inc.

Enclosed is a safety evaluation report (SER), to document the NRC staff's review of your request. The license amendment request is approved and documented in Amendment 4 of the SNM-2016 License. Having met the final actions required prior to termination, as discussed further in the SER, License SNM-2016 is hereby terminated. This termination is being issued in accordance with the requirements of Title 10 of the *Code of Federal Regulations* (10 CFR), Section 70.38. Upon issuance of a *Federal Register* Notice regarding the license termination, Enterprise Project Identification Code L-2019-LLA-0024 will be closed.
