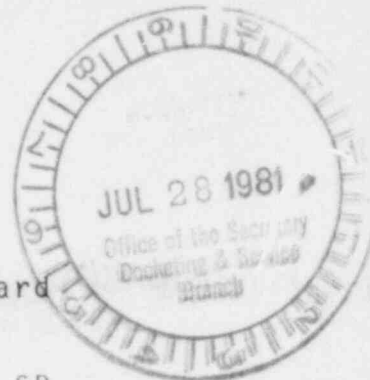

MOTION FOR EXTENSION OF TIME
TO FILE BRIEF

1. An expert in the field of health physics is needed to prepare the appellant-intervenor's brief.
2. Douglas King is the expert in the field of health physics used by the intervenor-appellant concerning the issues decided in the Final Order entered by the Atomic Safety and Licensing Board on June 19, 1981.
3. Due to prior teaching and research commitments, Douglas King has not been able until now to assist in the preparation of the brief of the intervenor-appellant.
4. Counsel for the intervenor-appellant will not be able to file a brief that will adequately and properly represent the interests of the intervenor-appellant until August 7, 1981.
5. Under 10 C.F.R. Sec. 2.711(a) this board has the authority

to grant an extension of time for filing this brief.

6. Counsel for the intervenor-appellant has consulted with counsel for the licensee and counsel for the NRC staff and is authorized to represent that the NRC staff has no objection to this motion while the licensee neither consents to nor opposes this motion.
